ORDINANCE No. 2 OF 2021 OF THE BOROUGH OF WEST HAZLETON AMENDING WEST HAZLETON BOROUGH FEE SCHEDULE FOR ZONING, CODE ENFORCEMENT AND PLANNING

The Borough of West Hazleton wishes to have a comprehensive ordinance that regulates fees assessed in the Borough for Zoning, Code Enforcement and Planning.

Now, THEREFORE, be it ordained by the Council of the Borough of West Hazleton, that the West Hazleton Borough Fee Schedule is amended to read as follows and the Boroughs Fee schedule is set forth as follows:

Building Permit:

[includes all required inspections except Plan Review & Fire]

NEW CONSTRUCTION

Residential, New Construction & Repair \$125.00 for the first \$5,000.00 of estimated projects costs, with a \$15.00 fee added for each additional \$2,000.00 projected cost.

Commercial: \$300.00 (+ 1% total* construction costs if inspection is conducted by Borough personnel)

ICC Building Valuation Data costs (Updated every six months by the ICC) maybe used to determine permit fees based on total project cost/building construction cost All Building Group types including Residential.

Re-Inspections (for failed inspections)

Residential \$50.00

Commercial \$150.00

Fence/Shed Permits: \$50.00

Swimming Pools: (electrical & plumbing)

Permit Application \$100.00 (in ground)

Permit Application\$50.00 (above ground)

Above ground Requires 2 inspections @ \$75.00

In ground Requires 3 inspections @ \$75.00

NOTE: ALL PERMITS: \$4.50 PA State Administration Fee

Excavations

Excavation: \$150.00 for the first 50 square feet and an additional \$100.00 for each additional 50 square feet. *

* Proof of Bond to be presented: Proof of General Bond in the amount \$250,000.00 liability per individual with \$500,000 personal injury, \$250,000 liability for property damage.

Sidewalk excavations: \$50.00 permit fee. All sidewalks being cut for utility access must be repaired with the same or comparable materials to match the surrounding sidewalks; Sidewalk resurfacing must comply with the Borough Code Chapter 355, Street & Sidewalks.

Freshly Paved Road: “Freshly paved” to be defined as any non-PennDot road owned by the Borough which has been paved within 4 calendar years of application. \$1500.00 for the first 50 square feet plus an additional \$400.00 for every additional 50 square feet.

Inspection Fee: \$65.00 per inspection.

Driveway Installation/Resurfacing Permit

Permit shall be obtained whether or not zoning is required - \$50.00 permit fee.

Sign Permits

\$35.00 for the first \$1000.00 of construction costs \$15.00 for each additional thousand dollars of construction costs.

ALL SIGNS SHALL BE SUBJECTED TO A YEARLY PERMIT FEE

- 1 sq ft. to 12 sq ft. \$25.00 per year.
- 12 sq/ft to 24sq/ft (each sign)\$50.00 per year.
- 24 sq/ft and larger (each sign).....\$75.00 per year.
- Billboard Signs/Pedestal Signs\$150.00 per year.
 - o A certificate of Insurance in the amount of \$100,000.00 must be supplied
 - o Denotes free standing or affixed to structure.

Plan Review Fee Schedule --- Commercial Construction

The Plan Review fee is based on the estimate construction value in accordance with the Square Foot Construction Costs Table (gross area x Square Foot Construction Costs) published by the International Code Council (ICC).

For building with an estimated construction value up to \$3,000,000.00, the Plan Review fee is 0.0015 of the estimated value (\$250.00 minimum). For buildings with an estimated value over \$3,000,000.00 up to \$6,000,000.00, the fee is \$4,500.00 plus 0.0007 of the estimated value over \$3,000,000.00. For buildings over \$6,000,000.00, the fee is \$6,000.00 plus 0.0005 of the valuation over \$6,000,000.00. Special considerations may be given in computing Plan Review fees for such large warehouses and repetitive floor plans such as high-rise buildings. This would be on a 'case by case basis' and approved by the Building Code Officials.

The Plan Review fee for Accessibility, Energy, Mechanical, Plumbing and Electrical Reviews are computed at 25% of the Building Plan Review fee for each discipline (\$250.00 minimum).

1 to 200 heads -- \$275.00
201 to 400 heads -- \$325.00
401 to 500 heads -- \$375.00
501 or more \$375.00 plus \$0.23 per head
